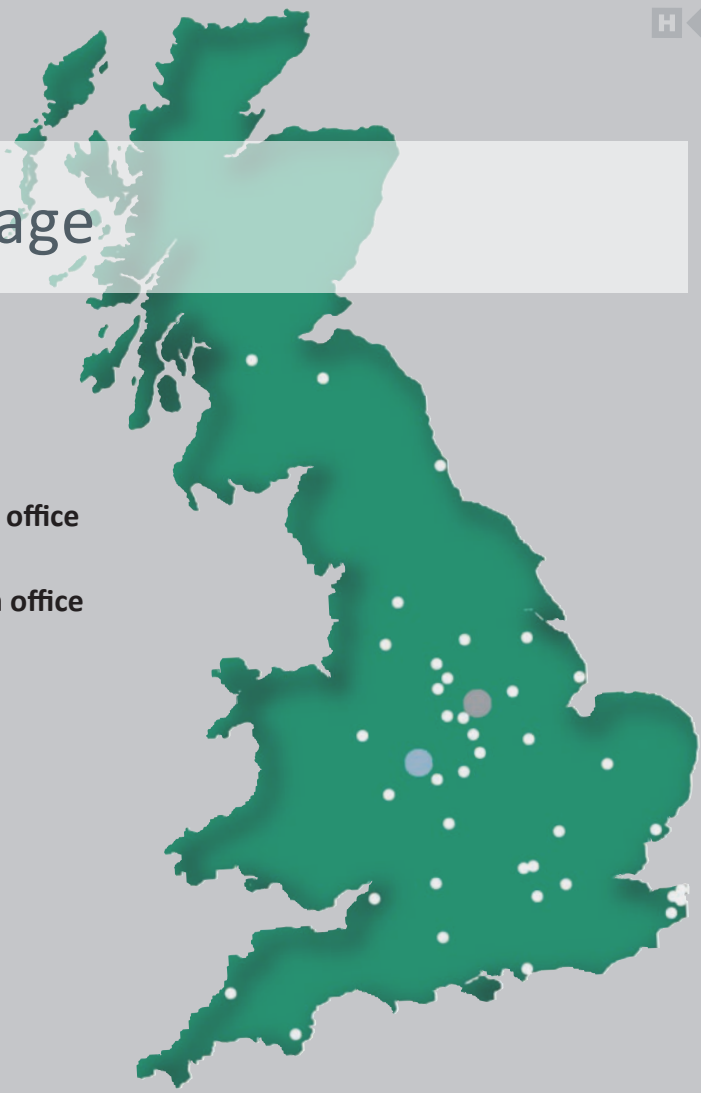

Hooley's, Nottingham

This design and build project comprised the construction of a new mixed-use city centre residential development comprising 172 one and two bedroom apartments and ground floor retail areas

Advanced Manufacturing Facility, Solihull

This £50m design and build project comprised the construction of a new 350,000ft² Global Engineering Centre of Excellence for 2,200 staff. The works included manufacturing, office and administration, kitchen, dining, welfare areas and extensive site works

MPP provided a full Project Management service including design watching brief and principal designer services

MPP also undertook the full management and co-ordination of the c£50m fitting out of the facility including the management and co-ordination of all services and new plant and equipment installations, catering facilities and office fit outs



Precision Casting Facility, Derby

This project comprises the refurbishment and upgrade of a 320,000ft² 1970's turbine blade foundry and production facility. The works include asbestos removal works, removal of multiple redundant services installations and full services renewal including critical life safety systems and environmental controls installations, new welfare, kitchen and canteen areas for 1,200 personnel, full façade renewal, and associated external works, services and drainage installations

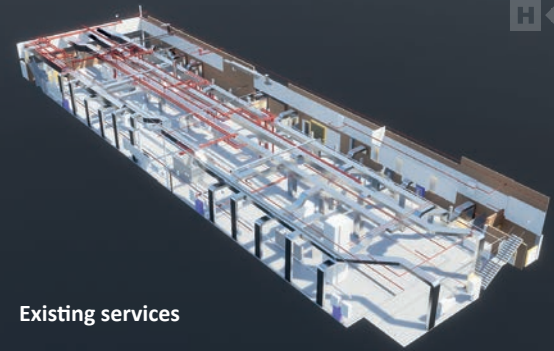

with a master delivery programme again developed by MPP

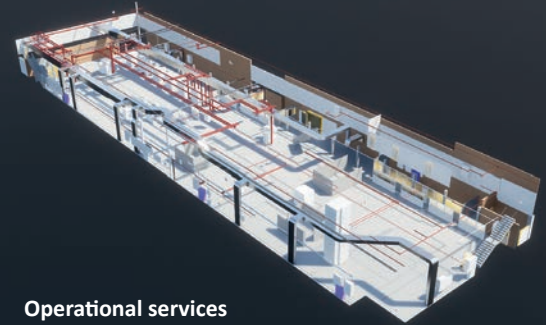

Nottingham High School

This project comprised the construction of a new three storey sixth form centre within an existing restricted school courtyard area. A feature ETFE transparent roof was incorporated as a key element of the works. New accommodation included classrooms, a lecture theatre, a sixth form common area and coffee bar as well as offices, a new kitchen, servery and dining hall facilities together with associated plant and storage areas
