

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **152.93** tCO₂e by 20**30**. This is a reduction of **30**%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 20**24** baseline. The carbon emission reduction achieved by these schemes cannot be calculated until the 2025 reporting year. Our aim is for these to equate to **210** tCO₂e, a **3.9**%ge reduction against the 20**24** baseline and the measures will be in effect when performing the contract.

Carbon Reduction Initiatives Scope 1 – Direct Emissions

- Transitioning company vehicle fleet to fully electric vehicles
- Optimising route planning to reduce fuel consumption
- Encouraging public transport and cycling for business travel where practical

Scope 2 - Indirect Emissions

- Procuring 100% renewable electricity through REGO-backed suppliers
- Implementing office efficiency measures:
 - Smart heating/cooling management
 - Motion-sensor lighting
 - o Equipment shutdown protocols when not in use

Scope 3 - Other Indirect Emissions

- Low-carbon commuting and remote-working policy
- Sustainable procurement and supplier engagement
- Client collaboration on renewable energy and energy efficiency
- Increased use of virtual meetings to reduce travel
- Waste minimisation and recycling initiatives

In addition, on an annual basis, the company participates in EcoVadis assessments to monitor and improve its environmental, social, and governance (ESG) performance, formalising its continual improvement processes.

Future carbon reduction initiatives

In the future we hope to implement further measures such as:

- Expand company vehicle fleet electrification across all operational vehicles by 2030
- Maintain and expand ISO 14001 and ISO 9001 standards across operations
- Increase use of virtual meetings to reduce business travel by 25%
- Implement office-wide energy management system to optimise electricity usage
